The contract notice is modified as follow:

The Article 16 of the Contract Notice (selection criteria) is slightly modified, due to an administrative error.

- Availability of a soil-stabilizing machines working to at least 2.5 m in width and 30 inches in depth is not requested as a technical/professional criteria.

**Original text:**

**Article 16: Selection criteria**

***Economic and financial capacity of candidate:***

(...)

***Technical and professional capacity of candidate:***

- a. The tenderer has completed at least 1 projects of the same nature as the works concerned by the tender (road and/or bike road construction) of and implemented during the following period: August 2009 – August 2014, worth of net HUF 200.000.000 at least. The reference may consist of no more than 2 lots.

The Contracting Authority reserves the right to ask for copies of certificates of final acceptance signed by the supervisors/contracting authority of the projects concerned.

This means that the project the tenderer refers to could have been started/implemented/completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period.

The following proof documents should be request: The list of the most important works carried out in the last 60 months, containing the following information:

- the name and address of the Contracting Authority or entity who ordered or purchased the works,
- the subject and short description of the works,
- A brief description of the subject and, in the case of more entities involved in the same reference, own performance certificate is required,

- Execution time (period), place of performance,
- The amount of the contract and the value of the performance in the case of more entities involved in the same reference, own performance certificate is required,
- The name and contact details of the person providing the reference information,
- Information showing that performance was, fulfilled according to the specifications of the contract

The contracting authority reserves the right to verify the performance of the works cited in the documents, by asking proof of documents from the technical supervisors (handover certificate / certificate of completion).

- b. The Tenderer must have certificates of EN ISO 9 001 accredited in any national system, or, lacking this, a proof about a system equalling to the standard.

The following proof documents should be request: the copy of the EN ISO 9 001 certificate or, lacking this, a proof about a system equalling to the standard.

- c. In each of the examined three years (2011, 2012, 2013.) the statistical average of the employees' number at the Tenderer must be at least 10 people.

The following proof documents should be request: a signed statement of the statistical average of the employees' number of the past three years.

- d. The Tenderer must have the following professional staff required in order to perform the task:
  - at least one responsible technical supervisor in charge who has a diploma in any kind of advanced studies and has at least 36 months of experience in managing blacktop road and/or bicycle route and/or footpath construction works.

Execution of the contract should only be started if the technical supervisor in charge has a certificate of MV-KÉ according to 266/2013. (VII.11.) governmental decree or MV-KÉ/A based on the 244/2006. (XII.5) governmental decree (or equivalent). The technical supervisor in charge has to be registered in the Hungarian Chamber of Engineers Register.

The following proof documents should be requested:

- CV signed by the expert (containing the general and special experience of the expert (marked in months), as well as the workplace of the expert,
- copy of the expert's diplomas or certificates
- copy of Hungarian Chamber of Engineers' certificate
- the statement of exclusivity and availability signed by the expert.
- at least one construction site manager, who has a diploma in any kind of advanced studies and has at least 36 months of experience in managing blacktop road and/or bicycle route and/or footpath construction works.

The following proof documents should be requested:

- CV signed by the expert (containing the general and special experience of the expert (marked in moths), as well as the workplace of the expert,
  - copy of the expert's diploma or certificates
  - the statement of exclusivity and availability signed by the expert.
- e. The tenderer is required to have the minimum technical equipment (machinery) as the following:
- 1 piece of soil-stabilizing machines working to at least 2.5 m in width and 30 inches in depth
  - 2 pieces of wheeled and / or tracked excavator min. 22t
  - 1. min combination backhoe loader, trench digger, 60W power
  - 3 Trucks min. 18 t gross weight
  - 1 piece of roller
  - 1 piece of vibratory compactor min. 9 t
  - 1 piece of road kerbs cylinder

  - 1piece of road kerbs cylinder
